- II. Consent Agenda Approved with no objections
 - Meeting Minutes
 - Special Membership
 - Dr. Sulbaran asked if GC documents can be shared with the departments/units
 - Dr. Tonzetich clarifies that there is no issue in sharing and all the documents are publicly available.
 - Clarissa shared the link in the TEAMS chat where GC documents can be found (https://graduateschool.utsa.edu/faculty-staff/council/minutes.html)

III. Reports

- A. Committee on Graduate Programs and Courses Dr. Tonzetich
 - MED HEAD Approved
 - Dr. Tonzetich presented the changes proposed in the Master of Education in Higher Education Administration (MED HEAD) which encompass the reduction of credit hours to the degree of compliance with other programs in the field, the addition of a Community College Leadership Concentration to complement existing concentration in Comprehensive University Leadership.
 - Dr. Thurow asked if the program representatives would present the proposed changes for an informed voting.
 - Dr. Tonzetich clarifies that the committee on graduate courses and programs reviews and approves the proposals and that the documents are shared with the graduate council via TEAM in advance for review before the meeting.
 - Dr. Tonzetich requested the GC vote on: "Do you approve of the changes to the MED HEAD degree including the addition of a concentration in Community College Leadership?"
 - Results of the voting were:

86% Approve 14% abstain *29 responses*

- Dr. Sulbaran asked if we can change the forms to request information on the impact on accreditation in these programs.
- Dr. Tonzetich responded that we cannot do it and Dr. Mathur confirms as the forms have been approved by many layers before.
- MS in Advanced Materials Engineering *Approved*
 - Dr. Tonzetich presented the proposed changes to the Masters of Science in Advanced Materials Engineering which is the addition of a new concentration in Semiconductor Materials and Manufacturing. Current concentrations existing in the program are Multifunctional Electronic, Dielectric, Photonic, and Magnetic Materials and Multifunctional Biomedical Materials
 - Dr. Tonzetich requested the GC vote on: "Do you approve of the new concentration in Semiconductor Materials and Manufacturing within the M.S. in Advanced Materials Engineering?"
 - Results of the voting were:

92% Approve 8% abstain 25 responses

- MS in Information Technology (addition of concentration) Approved
 - Dr. Tonzetich presented the proposed changes to the Masters of Science in Information Technology which is the addition of a new concentration in Cyber Analytics. The current concentration is in Cyber Security.
 - Dr. Tonzetich requested the GC vote on: "Do you approve of the new concentration in Cyber Analytics within the M.S. in Information Technology?"
 - Results of the voting were:

88% Approve 12% abstain *26 responses*

B. Council Chair

- Faculty senate updates
 - Dr. Tonzetich reported on senate updates the following points:
 - Joshua Gerken, Associate Vice President for Asset Management, visited the last Senate meeting to talk about space assignment but with little insight on the topic.
 - Dr. Shipley, Provost and Executive President for Academic Affairs, visited las Senate meeting and talked about the integration.
 - Other topics discussed by the senators to be addressed in the future by the
 administration and that concern Graduate Council are the IRM model and
 how it is being implemented, support for research, graduate education, and
 research infrastructure (space a critical point of discussion). More details on
 Senate meetings can be found through department/unit senator
 representatives.
- Reminder on faculty assignment to standing committees
 - Dr. Tonzetich thanked all the people who have agreed to serve and stepped forward to lead standing committees.

• Dr. Tonzetich comments on future new business in the GC to be brought forward by Dr. Mathur.

C. Dean of Graduate School

- AY 23/24 Graduate School recap
 - Presentation was shared in the meeting TEAMS chat.
 - Topics discussed include: The mission of the graduate school, enrollment, UTSA strategic plans, successful mentoring guidelines, reimagine the PhD project, bold doctoral journey to move to Canvas, postdoctoral affairs office, graduate students professional development activities available through UTSA, reimaginig the Masters (new initiative scholarships to increase retention)
 - Dr. Sulbaran asked what is the 2nd reason why MS students don't come back?
 - Dr. Mathur answered time, as many of them need to work
 - Dr. Cepek asked if the graduate school influences changing faculty loads to advise graduate students to accelerate graduation. In some programs, faculty needs to advise a large number of graduate students on top of traditional working loads, making it difficult to accelerate MS graduation time.
 - Dr. Mathur clarifies that Graduate School has no influence and has not heard of being discussed at the graduate level by upper administration.

- Vote on graduate catalog proposal to change the composition of MS/MA committees from a minimum of 3 to 2 faculty members Dr. Tonzetich *Approved*
 - Dr. Tonzetich called to vote and the results were:

88% Approve 4% Disapprove 7% Abstain 27 responses

• After Dr. Konove questions, Dr. Tonzetich clarifies that the change will be only for MS/MA programs effective for Fall 2025. Students who did not enter in the programs with that catalog can still follow this change if it is beneficial to the students as per graduate school standards.

V. New Business

• Reminder on Individual Development Plans (IDP) for graduate students – Dr. Tonzetich *Action to take by Graduate Council Members:* Stress the importance of IDP in your departments.
