II. Reports

A. Council Chair (Jurgen Engelberth)

- Consent Agenda
  - February minutes – approved with no discussion
  - Special memberships – approved with no discussion
- Senate Report
  - Provost presented an update on new classroom equipment
  - Discussed availability of option for 8-week course offerings (option has been made available within the past year)

B. Dean of Graduate School (Ambika Mathur)

- Announced South Texas Inter-disciplinary Research for Undergraduates Program (STIRUP) to better prepare undergraduate students for graduate school
  - Will be based on faculty-student mentorship and a cohort model to create opportunities for research and promote student diversity in research
  - Submit names of student nominees to Ambika Mathur (a flyer/ announcement will be sent out soon with additional information)
- Addressed council member question about whether the number of assistantship positions for programs is based on type of programs (e.g., doctoral vs. master's)
  - Ambika noted that decisions regarding allocation of resources and number of assistantships to different types of programs are made at the college level
- The report regarding from the ad hoc GAR committee will be shared prior to the April 2021 Graduate Council meeting
- The previously announced speaker series/presentations have begun, with two sessions complete; attendance has been poor (11 participants [other than

graduate school staff] attended the first presentation, 5 participants [other than graduate school staff] attended the second presentation)

- Important to continue to promote speaker series offerings to all faculty and graduate students
- Suggestion made to ask GRAs to attend presentations, send out more frequent notices/reminders about the presentations, and use TEAMS

C. Secretary (Victor Villarreal)

- Announcements have been sent to department chairs about electing and confirming Graduate Council members for next year, with a date of April 1<sup>st</sup> proposed to submit names for Graduate Council members for next year
  - Follow up with your Department Chairs to ensure that members are elected soon
